• Sales

- We have made significant changes to our discount strategy this fiscal year. We have retired our volume discount month strategy and introduced a new seasonal discount that offers a 15% discount off the entire shop every quarter. Our staff is thrilled with the new process, and it has given shoppers more time to make purchases. We are currently collecting data this quarter to compare it with our historical procedure, and we are confident that it will prove to be more effective for all. Total Coop sales were down by 2%, ending on 10/31/2023 when compared to the same month last year. However, we are pleased to report that the retail stores saw a 4% increase in transactions, despite the average basket size being down by 7%. We are excited about our new seasonal discount and the data we are collecting.

Round Up For Change

In October, our Co-op helped raise funds for the Roadrunner Food Bank as the recipient of our Round Up For Change program. Roadrunner is the largest non-profit dedicated to solving food insecurity in New Mexico. They provide to hundreds of member partners around the state including food pantries, soup kitchens, shelters and regional food banks. Every week, tens of thousands of hungry children, seniors and families are reached through this statewide hunger relief network. I am delighted to report that we raised a total of \$8,390 for our non-profit partner.

• Membership

- As of the end of October, our membership totaled 14,416, which is 17 more than the previous month. Additionally, one more member purchased a lifetime membership, bringing our total to 801. Other Updates October is designated as National Cooperative Month in the United States. We take pride in being a member of the NCG cooperative, which is comprised of 160 co-ops operating in 39 states. Our co-ops

collectively serve over 1.3 million consumer-owners and generate annual sales exceeding \$2.5 billion. We recently held our annual member gathering at the historic Hotel Andaluz in Albuquerque. The event was attended by over 40 member-owners who joined us that evening to hear about our cooperative's performance in the past fiscal year and our progress towards achieving our mission and Ends. This was the first in-person member gathering since the pandemic and I am delighted to report that the event was a great success, featuring amazing music, food, and updates about our coop. I am looking forward to attracting even more member-owners to attend this event next year!
