GM Report

Update:

- Sales ending Jan. 31, 2023 were up 6.42% compared to the same month last year.
- Memberships at the end of January were 14,2221 compared to last year at 14,093.
- The January Round Up for Change program recipient was Reunity Resources. Our coop successfully raised \$7,995 in January for our non-profit partner.
- We are excited to bring back our iconic EarthFest celebration this year. We are taking it back to where it all started, in front of our Nob Hill store. The fest is scheduled for Saturday, April 22, 2023.
- Avanyu Plaza Development. We have successfully completed Phase 1 and kicked-off Phase 2. This phase will include the Design Development and Contract Documents of the structure. By the end of the spring the coop will be seeking building permit approval.
- LMC completed the upgrade of our refrigeration system at the Nob Hill store and installed the new cheese and meat coolers. Starting next week, we will be replacing the entire Nob Hill produce department coolers.

GM Policy Monitoring Report

The Board voted unanimously to approve GM reports on Financial Conditions (L3), Communication and Counsel to the BOD (L6) and BOD Logistics Support (L7).

There was discussion about migrating off of the Basecamp platform for archiving Board documents to MS Teams. GM took the action to talk with IT to implement.

 - There was discussion on responsibility for candidate recruitment with agreement that this is responsibility of all Board members, with the NEC and BD committees having additional actions.
 - We discussed the role of Advisory Board Members and agreed to discuss this more as a Board rather than within NEC charter.

- o Board voted unanimously to accept Board Development Charter
- o First Board Development meeting March 7 6PM
- Policy Development Committee
 - There was agreement to accept the charter as written except for one point which the Board attempted to reword at the meeting. The decision was made to continue the discussion after the meeting and follow-up with an updated draft and email vote, to be noted at next month's Board mtg.
