# **GM Update – March 2024**

- Sales
  - O Total sales at our Coop for the month of February were down 1.6%, transactions at our retail stores were up 8.6% and the average basket size was down \$3.71 when compared to last year. The DC sales were down by 14% with transactions down 2.73%
- Round Up for Change
  - O Last month, the recipient of our Round Up for Change program was the Yerba Mansa Project, which is an Albuquerque-based community non-profit organization working to reestablish the connectivity of people, plants and the land in the Middle Rio Grande Valley. Their work supports the health of ecologically and culturally important native edible and medicinal plants and provides an opportunity for people to reclaim their role in caretaking our land and perpetuating our culinary and healing traditions. I am thrilled to report that we successfully raised \$6958 for the Yerba Mansa Project.
- Other News
  - The construction of our new store location on the Avanyu Plaza campus in Albuquerque is progressing well and the building shell is expected to be completed by

the end of this month. Our management team is working closely with our landlord's general contractor, Jayne's Corp., on the Tenant Improvements contract, which includes the bidding process for plumbing, electrical and HVAC procurement. I would like to express my gratitude to all the La Montanita Coop Board Members and volunteers who have contributed their efforts alongside the management team to bring our project to this point.

## **GM Monitoring Reports**

• L2 – Staff Treatment – The Board voted unanimously to accept the report after some discussion noting that this year's employee survey showed improvement over last year in most of the topics covered, and clarifying that the survey is benchmarked against other retail grocery businesses.

## LMC EarthFest planning - Leah

- Our event this year will be Sunday, April 21<sup>st</sup> from 10 to 4, very similar to last year's successful event. The event will be at the same location at the Nob Hill store parking lot with increased the vendor capacity. Scalo and Gecko's will be promoting the event and will graciously allow attendees to use their restrooms
- A booth for Co-op Management and the Board will be in the same place as last year (SE corner). There will be at least 1 Marketing and 1 Board member present at all times. Ching will be scheduling 3 2-hour slots for board members and will send a reminder 2 days in advance.
- Plans include having have a bingo card promotion with one square for each booth and aa square for speaking with a Board member, which will be an opportunity for Board members to chat with members to see if they are interested in running for the Board.
- Brian wrote an article on our Sustainability Ends for the Scoop and the Climb that fits very well with this year's global EarthFest them of "Planet vs. Plastics".

# Report from Finance Committee - Brian

- GM delivered a report for period 5, including steps for improvement.
- Sales were up 4.7%
- Seeing inflation decreasing, finally
- Operating/Net income improving, even though they did not meet the benchmark
- We beat the budget by \$513
- Labor was a bit higher
- Memberships still growing with 800 lifetime members
- Average Cash on Hand calculation across coops is 15 days
- Our GAAP certification will be reflected in our numbers next month or the month after
- January just missed the benchmark but it was better
- In December we started tracking spoilage which resulted in a 1.5% improvement
